Year 3 Swimming

Once again we are very pleased to be able to provide swimming at Chilton Trinity Technology College Bridgwater next term. This meets with the National Curriculum Physical Education Programme.

Year 3's will attend swimming lessons on a weekly basis for **11 weeks** from Tuesday **18th April** until Tuesday **4th July 2017**. The children will travel to Chilton swimming pool during the afternoon, and will be back for **3.00 pm**. The children will be transported by Rendalls Travel.

The cost of this activity is being subsidised by the school and the voluntary contribution for pupils is **£2.50** per week to go towards the hire of the coach and two swimming instructors. If you prefer you can pay the whole **£27.50** for this terms swimming in one go, cheques should be made payable to Hamp Academy. Alternatively, you can pay weekly sending in the correct money in an envelope with the child's name, class and swimming written on the front on the morning of the lesson.

Please note that these payments are a voluntary contribution, but if not enough parents contribute then swimming may not be able to take place.

All pupils need to return the fully completed consent form by no later than **Friday 17th March 2017**.

Please note that children must wear appropriate costumes and bring a towel. Girls should wear a one-piece costume, not two-piece and boys should wear trunks, not long Bermuda shorts. Please ensure that all swimming kit is named.

Unfortunately those children who fail to return the consent form will not be able to attend until the consent form is fully completed and returned.
